In supersession of the notification issued vide No. Admission/24/5984-6083 dated 06-06-2024, it is hereby notified for the information of all concerned that the admissions to **Semester-3rd & 5th** of Four Year Under Graduate Programme under National Education Policy (NEP)-2020 in all Govt. and Non-Govt. colleges affiliated of the University of Jammu shall be made as per schedule given as under:-

- a) 07-06-2024 to 27-06-2024 (without late fee)
- b) 28-06-2024 to 08-07-2024 (with late of Rs.380/-)
- c) The Vice-Chancellor may consider grant of the late admission for 10 days after the expiry of last date of admission on payment of late fee of Rs. 3520/- subject to the condition that wherever income of a candidate's parents is below poverty line (BPL) he/she be exempted from the payment of Rs.3520/-. However, late fee shall be charged in such cases as prescribed at (b) above.

The regular teaching work of class shall begin from First week of August, 2024.

Eligibility Criteria:

For Semester-3rd - A student will be eligible for promotion from semester-II to semester-III provided he/she has earned atleast 50% of the total credits of semester-I and have passed in Internal Assessments of all papers of semester-II.

For Semester-5th - A student will be eligible for promotion from semester-IV to semester-V provided he/she has passed till semester-II and 50% of the total credits of semester-III and have passed in Internal Assessments of all papers of semester-IV.
